Virtually all major components of your vehicle are covered, providing you with an unprecedented level of mechanical protection after your factory warranty expires.

Engine | Engine block, heads and all internal and external parts.

Transmission | Transmission case and all internal and external parts.

Infotainment | Key audio, video and navigation system components.

Air Conditioning & Heater | All internal and external parts including compressor, clutch, pulley, seals and valves.

Fuel System | Fuel tank/delivery systems; injection sensors/modules; emissions systems.

Advanced Driver Assistance System (ADAS) | Intelligent Cruise Control, Blind Spot Warning system, various camera systems, sonars and sensors.

Brakes | All internal and external parts including Anti-Lock Brake System (ABS).

Lubrication & Cooling | Radiator and all internal and external lubrication and cooling parts.

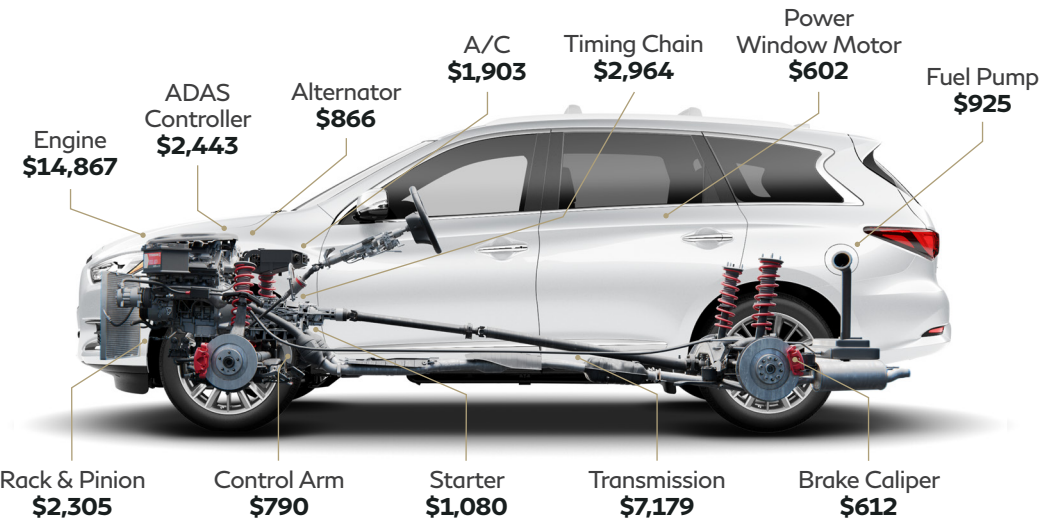
