UV Body Panel and Warning Labels

Display a permanent and unique code on a vehicle that is visible under UV light, allowing law enforcement agencies to identify the owner of a recovered vehicle.

COVERAGE DETAILS

Retailer Replacement Benefit*

In the event your vehicle is stolen and not recovered or otherwise determined to be a total loss, you will be eligible for a credit toward your replacement vehicle in the amount of the maximum benefit (\$2,500 or \$5,000) if you return to the selling retailer. You will be eligible for an additional credit of \$1,000 if you purchase a new vehicle from the same OEM from the selling retailer. If you do not return to the selling retailer, but purchase a new vehicle from the same OEM, you will be reimbursed \$1,000. If you do not return to the selling retailer and do not purchase a new vehicle from the same OEM, you will be reimbursed \$500.
